Program Description

The Master of Education in Human Relations is a theoretical, non-practitioner program designed for individuals in the business world, the military, and education, who want preparation in the facilitation of learning and/or an understanding of human behavior, the learning process, and interpersonal communication skills. Students admitted for Fall 2009 and after have the option of completing this degree online.

The Master of Education in Human Relations **does not lead to licensure/certification as a Counselor.** To be eligible for professional counselor licensure, you must be admitted and complete all the requirements for the M.A. Counseling program. It is also not the university's official school counselor preparation program and therefore does not lead to school counselor endorsement by the Certification Unit of the Arizona Department of Education. To be eligible for the school counselor endorsement, students must be admitted to and complete all the requirements for M.Ed. in School Counseling.

1. Complete the **online combined** (Graduate College and Department) application at: <http://www.applyweb.com/apply/northazg/>
2. **Submit official transcripts** from all previous universities attended to: **Graduate College, Box 4125, NAU, Flagstaff, AZ 86011-4125.**
3. **Submit 3 form letters of recommendation** to the Educational Psychology office: **Department of Educational Psychology Box 5774, NAU, Flagstaff, AZ 86011.** Recommendation forms can be obtained by visiting the Educational Psychology Department website at <http://coe.nau.edu/academics/eps/> and clicking on Application Process.

4. If you are a student planning to complete this program at NAU-Yuma or at a Distance Learning site, **you must secure advisement from the Extended Campus Coordinator at the location you will be taking most of your courses prior to being admitted into the program.** Once you secure advisement, your application will be reviewed. Admission decisions are made periodically throughout the year. Admission notifications are made by mail.
5. If your transcripts show a **Grade Point Average of 3.0 or better, or if you have taken the GRE General Test within the past six years and scored at or above the 25th percentile, you are ready to be considered for admission.**
6. If you have not met the criteria in #5, you may qualify for admission by taking **9 NAU graduate hours approved by an advisor, with a GPA of 3.0 or better.**

Application Deadlines

Admission decisions will be made periodically throughout each semester once you have completed all steps in the admission process.

Transfer of Credits Policies

All requirements for this Master's degree, including courses accepted as transfer credit from other institutions, must be completed within six years after you have been fully admitted to Graduate Regular status. To be considered for transfer credit, your courses must:

- have been earned with a grade of A or B. (we will accept a pass grade if the course is graded only on a pass/fail basis;
- have been earned within the six-year period required for completing your degree at NAU;
- be applicable to a graduate degree at the institution where the credit was earned.

The number of hours you transfer from other institutions cannot exceed twenty-five percent of the total minimum credit hours required for your master's degree. With the approval of your advisor, you can use up to 9 credit hours of coursework from a previous master's degree to satisfy the requirements for a second master's degree at NAU. You must meet all program requirements for the second master's degree, and all but the 9 hours must be earned at NAU. The attached program of studies is used as a verification document when you apply for graduation. You should complete a program of studies with your advisor during the first semester of graduate work. The original signed copy should be placed in your folder in the Educational Psychology office, and copies should be kept by you and your advisor. Grade Point Average Policies

The Department of Educational Psychology adheres to grade point average guidelines established through the Graduate College. Students must maintain a 3.0 grade point average for all courses previously taken and for all courses required in their program. A grade below C does not earn graduate credit and if you have more than six hours of graduate work with a C or below, you cannot continue in your Masters program.
